LOPEZ, et al., 8 Defendants. 9 Plaintiff, a state prisoner, filed the present pro se prisoner complaint under 42 U.S.C. § 1983. 10 On December 9, 2011, mail directed to Plaintiff by the Court was returned to the Clerk of the Court 11 with a notation that it was undeliverable because he had been "discharged." To date, Plaintiff has 12 not updated his address with the Court or submitted any further pleadings in this case. 13 Pursuant to Northern District Local Rule 3-11 a party proceeding pro se whose address 14 changes while an action is pending must promptly file a notice of change of address specifying the 15 new address. See L.R. 3-11(a). The court may, without prejudice, dismiss a complaint when: 16 (1) mail directed to the pro se party by the court has been returned to the court as not deliverable, 17 and (2) the court fails to receive within sixty days of this return a written communication from the 18 pro se party indicating a current address. See L.R. 3-11(b). 19 More than sixty days have passed since the mail directed to Plaintiff by the Court was 20 returned as undeliverable. The Court has not received a notice from Plaintiff of a new address. 21 Accordingly, the complaint is DISMISSED without prejudice pursuant to Rule 3-11 of the Northern 22 District Local Rules. The Court has rendered its final decision on this matter, therefore, this Order 23 TERMINATES Plaintiff's case. 24 IT IS SO ORDERED. 25
