**STIPULATION AND [PROPOSED]  
 ORDER TO EXTEND DEADLINES**

25 Plaintiffs and Defendants in People v. Federal Housing Finance Agency, et al., Case No.  
 26 10-cv-03804-CW, and the three related cases, hereby stipulate that the deadlines for answers to  
 27 the complaints, fact discovery, and expert discovery shall be extended by approximately thirty  
 28 days. The parties stipulate that the existing deadlines shall be modified to the new deadlines set

 2 dispositive motions, the final pretrial conference, or the beginning of trial.

**PROPOSED ORDER**

15 Based on the Court's review of the above stipulation, the Court hereby orders that the  
16 deadlines in People of the State of California ex rel. Harris v. Federal Housing Finance Agency,  
17 et al., Case No. 10-cv-03804-CW, and the three related cases, shall be modified as follows:

- 18 • The deadline for Defendants' answers to the complaints is extended to October 17, 2011.
- 19 • The deadline for completion of fact discovery is extended to November 14, 2011.
- 20 • The deadline for disclosure of identities and reports of expert witnesses is extended to  
21 December 19, 2011.
- 22 • The deadline for rebuttal disclosure of identities and reports of expert witnesses is  
23 extended to January 20, 2012.
- 24 • The deadline for completion of expert discovery is extended to February 24, 2012.

25 IT IS SO ORDERED. **The pretrial conference will be held on June 13, 2012 at 2 pm.**
