22 **STATEMENT**

23 Plaintiffs filed their Complaint for Breach of Collective Bargaining Agreement, To  
24 Recover Unpaid Trust Fund Contributions, for Breach of Fiduciary Duty and for a Mandatory  
25 Injunction ("Complaint") on July 29, 2010, seeking to recover past due employee fringe benefit  
26 contributions on behalf of C and C Concrete, Inc.'s covered employees.

1 Defendants were served on August 6, 2010. Defendants failed to file a responsive  
2 pleading. On September 3, 2010 Plaintiffs filed their Request For Clerk's Entry of Default. On  
3 September 8, 2010 The Request for Clerk's Entry of Default was granted.

4 Defendants and Plaintiffs are still in direct negotiations in an attempt to resolve the  
5 matter prior to further litigation. Plaintiffs respectfully request that this Court allow the parties
