**STIPULATION AS TO THE JOINDER OF  
 DEFENDANTS SVC-WEST, L.P. AND  
 SVC-HAWAII, L.P. IN THE PARTIES'  
 PREVIOUSLY-FILED STIPULATION  
 AND PROPOSED ORDER RE: STAY OF  
 PROCEEDINGS**

1           1. Pursuant to Civil Local Rules 7-1(a)(5) and 7-12, Plaintiffs Jianming Song, Melissa  
2 Hetzel, Jeanette Ramos, Alma Palacios, Benny Pallan, Danish Mendiola, and Jade Smith  
3 (collectively, "Plaintiffs"), and Defendants Shell Vacations LLC, Shell Holdings, Inc., SVC-  
4 Northeast, L.P. (now known as SVC-East, L.P.), SVC-West, L.P., and SVC-Hawaii, L.P.  
5 (collectively, "Defendants"), jointly by their respective attorneys, hereby submit this Stipulation  
6 as to the Joinder of Defendants SVC-West, L.P. and SVC-Hawaii, L.P. in the Parties' Previously-  
7 Filed Stipulation and Proposed Order Re: Stay of Proceedings, which was filed on August 18,  
8 2010.

9           2. Defendants SVC-West, L.P. and SVC-Hawaii, L.P. had not been served in this case  
10 prior to September 2, 2010.

11           3. As a result, SVC-West, L.P. and SVC-Hawaii, L.P. were not parties to this case at  
12 the time the parties filed their August 18, 2010 Stipulation and Proposed Order Re: Stay of  
13 Proceedings (the "August 18 Stipulation").

14           4. On September 2, 2010, the attorneys for Defendants executed Waivers of the  
15 Service of Summons for SVC-West, L.P. and SVC-Hawaii, L.P.

16           5. The parties agree and stipulate that SVC-West, L.P. and SVC-Hawaii, L.P. should  
17 be subject to the August 18 Stipulation.

18           WHEREFORE, the parties hereby stipulate to the joinder of Defendants SVC-West, L.P.  
19 and SVC-Hawaii, L.P. in the parties' August 18 Stipulation.
