14	institution, or abide by such order of the above-entitled Court as shall thereafter be made
15	concerning the custody of said prisoner, and further to produce said prisoner at all times
16	necessary until the termination of the proceedings for which his testimony is required in this
17	Court.

19	Yocom's new custodian with a copy of this writ in that or ni.ES DISTRIC?
