ORDER DENYING PETITIONER'S
SECOND MOTION FOR APPOINTMENT
OF COUNSEL; AND GRANTING HIM AN
EXTENSION OF TIME TO FILE A
TRAVERSE

12 Petitioner, a state prisoner, filed a pro se petition for a
13 writ of habeas corpus. The Court directed Respondent to file an
14 answer to the petition and granted Petitioner leave to file a
15 traverse within sixty days after the answer was filed. On December
16 23, 2010, Respondent filed an answer. Sixty days have passed, and
17 Petitioner has not filed a traverse.

18 Before the Court is Petitioner's second motion for appointment
19 of counsel to represent him in this action. The Court previously
20 denied Petitioner's first request for appointment of counsel. For
21 the same reasons, Petitioner's second request for appointment of
22 counsel is DENIED.

23 Now that it has ruled on his second request for appointment of
24 counsel, the Court on its own motion GRANTS Petitioner an extension
25 of time to file a traverse. Petitioner shall file his traverse no
26 later than thirty (30) days from the date of this Order. Should
27 Petitioner fail to do so, the petition will be deemed submitted and
28 ready for decision on the date his traverse is due.
