1 IT IS HEREBY STIPULATED by and between Plaintiff Alexx, Inc. (“Alexx”) and
2 Defendant Triple C Designs, Inc. (“Triple C”), by and through their counsel of record as follows:

3 WHEREAS, the initial Case Management Conference is currently set for April 5, 2011;

4 WHEREAS, on February 7, 2011, the parties attended a Settlement Conference before
5 Magistrate Judge Ryu, but were unable to reach a settlement (D.I. 25);

6 WHEREAS, the parties agreed to continue settlement discussions and contact Magistrate
7 Judge Ryu’s chambers within one week from February 7, 2011 to schedule a date for a further
8 Settlement Conference (D.I. 25);

9 WHEREAS, the parties had several discussions with Judge Ryu’s chambers regarding
10 settlement, and such discussions are ongoing;

11 WHEREAS, the parties respectfully request the Court continue the Case Management
12 Conference currently scheduled for April 5, 2011 by six weeks to May 17, 2011 so that the
13 parties can pursue further settlement discussions;


14 WHEREAS, there have been no other previous time modifications in the case, whether
15 by stipulation or Court order, except, pursuant to stipulation filed October 8, 2010 (D.I. 4), the
16 deadline for Triple C to answer Alexx’s Complaint was extended to November 11, 2010;
17 pursuant to stipulation filed November 22, 2010 (D.I. 15), the initial Case Management
18 Conference was postponed to February 22, 2011; and pursuant to stipulation filed February 9,
19 2011 (D.I. 26), the initial Case Management Conference was postponed to April 5, 2011.

20 NOW, THEREFORE, pursuant to Civil Local Rule 6-2, the undersigned parties hereby
21 stipulate and respectfully request the Court order as follows:

22 1. The Tuesday, April 5, 2011 Case Management Conference shall be continued to
23 Tuesday, May **24**, 2011 at 2:00 p.m. in Courtroom 2, 4th Floor, 1301 Clay Street, Oakland, CA
24 94612, or such other date as the Court may order.

25 PURSUANT TO STIPULATION, IT IS SO ORDERED.
