3 IT IS HEREBY ORDERED THAT:


4 1. The Court approves Class Notice substantially conforming to the Class Notice
5 prepared by Plaintiffs Mario L. Orsolini and Andrew M. Levine, and filed as Exhibit A hereto, as the
6 best notice that is practicable under the circumstances.

7 2. Within five (5) business days following the entry of this Order, Defendants
8 Mead Clark Lumber Co. AKA Mead Clark Lumber Company, Inc., and Randal J. Destruel will
9 provide directly to Class Counsel a list (in electronic form) containing the names and last known
