**ORDER DENYING PLAINTIFF LEAVE  
TO CONTINUE IN FORMA PAUPERIS  
STATUS ON APPEAL**

11 Plaintiff, a California prisoner proceeding pro se, filed a civil rights complaint under 42  
12 U.S.C. 1983 against California Supreme Court Chief Justice George, Justices Kennard, Baxter,  
13 Werdegar, Chin, Moreno and Corrigan, as well as Chief Clerk Ohlrich. Plaintiff claimed that  
14 Defendants, who are mostly state supreme court justices, violated his constitutional rights when they  
15 issued an August 27, 2008 decision. Plaintiff sought money damages and to be removed from  
16 "unlawful CDC&R custody/jurisdiction." (Compl. at 4.)

17 In an Order dated April 20, 2011, the Court dismissed the instant case for failure to state a  
18 cognizable claim under section 1983. The remaining claim for relief in the form of his release from  
19 custody was dismissed without prejudice to raising it in a petition for writ of habeas corpus.

20 Plaintiff had been granted leave to proceed in forma pauperis (IFP) in a separate Order.

21 On May 2, 2011, Plaintiff filed a notice of appeal.

22 In a Referral Notice dated May 12, 2011, the Ninth Circuit Court of Appeals referred this  
23 case to the district court "for the limited purpose of determining whether in forma pauperis status  
24 should continue for this appeal whether the appeal is frivolous or taken in bad faith." (Ninth Circuit  
25 May 12, 2011 Referral Notice at 1.)

26 A prisoner must seek leave to proceed IFP on appeal in the district court. See Fed. R. App.  
27 P. 24(a). As in the district court, a prisoner proceeding IFP on appeal will be required to pay the full  
28 filing fee. See 28 U.S.C. § 1915(b)(1).

1           If the district court finds that the appeal is frivolous and not taken in good faith and revokes  
2 IFP status, or if the prisoner never had such status and moves in the Ninth Circuit to proceed IFP, the  
3 Ninth Circuit will conduct an independent review of the record to determine whether the appeal is  
4 frivolous. The Ninth Circuit will decide whether to grant the prisoner IFP status. If IFP status is  
5 denied by the Ninth Circuit, the prisoner will nonetheless be directed to pay the entire filing fee and  
6 to show cause why the appeal should not be dismissed as frivolous. See id. § 1915(e)(2).


7           Plaintiff is appealing this Court's Order which dismissed the complaint for failure to state a  
8 claim for relief. As such, Plaintiff's IFP status should not continue on appeal because this Court  
9 finds that the appeal is not taken "in good faith" pursuant to 28 U.S.C. § 1915(a)(3). See Coppedge  
10 v. United States, 369 U.S. 438, 445 (1962); Gardner v. Pogue, 558 F.2d 548, 550 (9th Cir. 1977)  
11 (indigent appellant is permitted to proceed IFP on appeal only if appeal would not be frivolous).
