Soccer Co., Inc. v. Score First Enters., 187 F.3d 1108, 1110 (9th Cir. 1999). Defendants Katpana Sundaram, et al., have not answered Plaintiff's complaint or moved for summary judgment. Accordingly, Plaintiff's action is dismissed.
