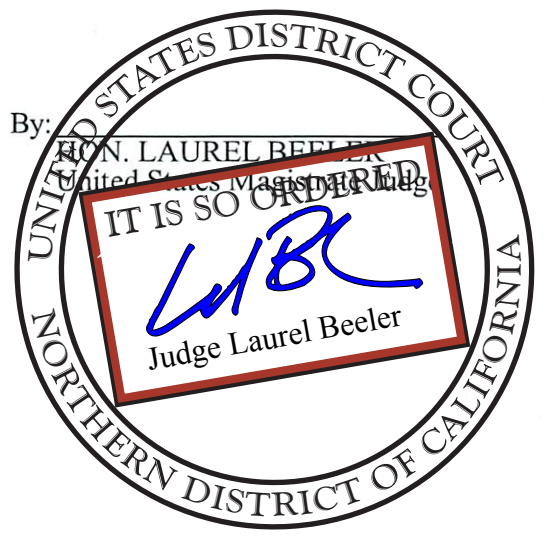
5 **PROPOSED** ORDER
