 21 this Stipulation Extending Time To File Reply Papers with reference to the following facts:

22 On April 17, 2012, plaintiff filed her Motion to Preclude Defendant from Using Late
 23 Produced Documents at Trial; for Default or Dismissal in Favor of Plaintiff if it Pleases the Court; for
 24 Attorney Fees and Costs; and for Other Sanctions Deemed Appropriate by the Court ("Sanctions
 25 Motion"). The Sanctions Motion was originally set for hearing on May 22, 2012, but on April 24,
 26 2012, the Court continued the hearing date to June 15, 2012. The Court did not change the dates for
 27 opposition or reply papers. On May 1, 2012, the County filed its Opposition to the Sanctions Motion
 28 based on the briefing schedule mandated by the original May 22, 2012 hearing date.

The deadline for filing reply papers based on the original briefing schedule is May 8, 2012. In
