16 David-Wynn Miller, and Syntax.¹ Docket No. 9. Plaintiffs failed
17 to oppose timely. The Court issued an order stating that
18 Plaintiffs shall file their opposition by May 4, 2011, or their
19 action will be dismissed for failure to prosecute. Docket No. 15.

20 The Court has received the filing submitted by Plaintiffs on
21 April 26, 2011. Docket No. 16. This submission could be
22 Plaintiffs' opposition. However, like Plaintiffs' complaint, the
23 submission is unintelligible. The Court will allow until May 4,
24 2011 for Plaintiffs to submit an intelligible opposition to

by the surname Campos.


1 Defendant JPMorgan Chase Bank, N.A.'s motion to dismiss. If
