1 WHEREAS, on or about March 7, 2011, Plaintiff served its Original Complaint upon
2 Defendant; Plaintiff's Original Complaint alleges counts for patent infringement, including
3 direct infringement, induced infringement, and contributory infringement;

4 WHEREAS, Plaintiff filed its First Amended Complaint on June 10, 2011;

5 WHEREAS, at the September 22, 2011 Status Conference, the parties discussed the
6 circumstances under which MasterObject's newly allowed patent application would be
7 asserted in this action;

8 WHEREAS, U.S. Patent No. 8,060,639 issued to MasterObjects on November 15,
9 2011;

10 WHEREAS, Plaintiff intends to seek leave to file its Second Amended Complaint,
11 whereby Plaintiff no longer alleges (and hereby withdraws its earlier allegations) that
12 Defendant infringes under 35 U.S.C. §§ 271 (b) or (c).

15 Plaintiff may seek leave from the Court to file its Second Amended Complaint, attached
