**ORDER GRANTING LOCAL
 CIVIL RULE 6-2 JOINT
 STIPULATED REQUEST TO
 EXTEND TIME TO RESPOND TO
 CLASS ACTION COMPLAINT
 AND SET BRIEFING SCHEDULE**

[PROPOSED] ORDER GRANTING STIPULATION TO
 EXTEND TIME TO RESPOND TO CLASS ACTION
 COMPLAINT AND SET BRIEFING SCHEDULE

1 Pursuant to Civil Local Rule 6-2, the parties hereto have filed a stipulation
2 extending the time for Defendants American Society of Reproductive Medicine
3 (“ASRM”) and Society of Assisted Reproductive Technology (“SART”) to answer
4 or otherwise respond to Plaintiff Lindsay Kamakahi’s Class Action Complaint and
5 setting a briefing schedule in the event that any Defendant in this action files a
6 motion to dismiss.

7 **PURSUANT TO STIPULATION, IT IS SO ORDERED** that:

8 1. The time for Defendants ASRM and SART to answer or otherwise
9 respond to the complaint, which is currently May 20, 2011 for ASRM, and May 24,
10 2011 for SART, is extended until June 24, 2011.

11 2. In the event that any Defendant in this action shall file a motion to
12 dismiss Plaintiff’s Class Action Complaint, the briefing schedule on such motion
13 shall be as follows:

14 Motion to Dismiss and Supporting Memorandum:	June 24, 2011
15 Plaintiff’s Memorandum in Opposition:	July 25, 2011
16 Reply Memorandum	August 15, 2011

17 3. The hearing on any motion to dismiss is scheduled for the next available
18 date of October 18, 2011 at 1:00 p.m. Pursuant to Federal Rule of Civil Procedure 78(b)
19 and Civil Local Rule 7-1(b), the Court, in its discretion, may resolve the motion without
20 oral argument. The parties are advised to check the Court’s website to determine whether
21 a court appearance is required.
