**STIPULATION AND [PROPOSED] ORDER
 TO CONTINUE CASE MANAGEMENT
 CONFERENCE**

IT IS HEREBY STIPULATED by and between the parties:

22 Plaintiff Anthony Johnson filed the complaint in this action on May 31, 2011. At the time he
 23 filed the complaint, the clerk did not provide him with copies of the Court's May 31 Order Setting
 24 Initial Case Management Conference and ADR Deadlines (the Order). Johnson is appearing *pro se*.
 25 Johnson was not aware of the Order until he received a call from Deputy City Attorney Jonathan
 26 Rolnick on or about August 9, 2011. The City's counsel had called to arrange a time for the parties to
 27 meet and confer as required by the Order.

1 The parties met on August 26 regarding the preparation of a joint case management conference
2 statement. At that time, the City's counsel provided Johnson with a copy of the Order and the Court's
3 General Order regarding joint case management statements.

4 Given Johnson's lack of notice regarding the Order and his unfamiliarity with the requirements
5 for a joint case management conference statement, he was unprepared to fully engage in the
6 preparation of such a statement. In order to provide Johnson with sufficient time to engage
7 meaningfully in the preparation of a joint case management conference statements, the parties request
8 a continuance of the September 8, 2011 case management conference including a corresponding
9 continuance for the time to file a joint case management conference statement and to make initial
10 disclosures. The parties request that the case management conference be continued from September 8,
11 2011 to October 6, 2011 or as soon thereafter as a case management conference may be held.


