1 WHEREAS, the Case Management Conference in this action is currently set for
2 January 11, 2012, at 2:30 p.m.; and

3 WHEREAS, the Rule 26(f) Report and joint Case Management Conference statement is
4 due by December 30, 2011; and

5 WHEREAS, Plaintiff craigslist, Inc. and Defendant Paul Agner (collectively “the parties”)
6 have cooperated in discovery efforts to investigate the relevant facts and issues in the case; and

7 WHEREAS, the parties have stipulated to a private ADR process (Dkt. #14); and

8 WHEREAS, the parties are currently making progress toward the complete resolution of
9 the case through productive settlement discussions, and believe prospects for settlement without
10 the need for costly litigation or significant expenditure of judicial resources are reasonably good;
11 and

12 WHEREAS, the parties believe it most efficient to continue the Case Management
13 Conference until March 15, 2012, or thereafter, so they can attempt to finalize a written
14 settlement agreement and thereafter file papers to fully resolve this litigation;

16 follows:

18 2:30 p.m., to March 15, 2012, or thereafter; and
- 19 2. The Joint Case Management Conference Statement and Rule 26(f) Report should be filed
20 no later than ten (10) days prior to the Case Management Conference.
