Before the Court is Plaintiff's motion for 12 an extension of time to file an amended complaint due to his lack of access to the prison's law 13 library. (Docket no. 8.) On June 21, 2012, Plaintiff filed a document entitled, "Notice And Request 14 to Place Case in Abeyance." (Docket no. 9.) Plaintiff again claims that he lacks access to the 15 prison's law library, but he now requests that "the case be placed in abeyance." (June 21, 2012 Mot. 16 at 2.) 17 Plaintiff's June 21, 2012 filing appears to request an indefinite extension of time in which to 18 file his amended complaint. This request (docket no. 9) is DENIED. The Court, however, 19 GRANTS Plaintiff's motion for an extension of time (docket no. 8), and the time in which Plaintiff is 20 permitted to file his amended complaint is extended up to and including twenty-eight (28) days 21 from the date of this Order. 22 If Plaintiff fails to file an amended complaint by the deadline above, this action will be 23 dismissed. 24

This Order terminates Docket nos. 8 and 9.
