adjudication no later than June 30, 2015.

10	certification for the remaining certified claims. The parties shall revise the notices in the manner as
11	stated on the record and confirm that the notices will be mailed by May 8, 2015.
12	(9) Upon further reflection on the parties' arguments, the opt-out postmark deadline shall be
13	June 24, 2015. The revised form of notice shall so reflect.
