ORDER DENYING MOTION FOR
APPOINTMENT OF COUNSEL

12 The Court has reviewed Plaintiff's Motion for Appointment of Counsel.

13 In contrast to criminal proceedings, there generally is no constitutional right to counsel in civil
14 actions. *United States v. 30.64 Acres of Land*, 795 F.2d 796, 801 (9th Cir. 1986) ("There is normally
15 ... no constitutional right to counsel in a civil case."). In proceedings *in forma pauperis*, the Court
16 has the statutory power only to "request an attorney to represent any person unable to afford counsel."
17 28 U.S.C. § 1915(e)(1). This decision of whether to request counsel is within the discretion of the
18 district court and is "granted only in exceptional circumstances." *See Agyeman v. Corr. Corp. of Am.*,
19 390 F.3d 1101, 1103 (9th Cir. 2004) (quoting *Franklin v. Murphy*, 745 F.2d 1221, 1236 (9th Cir.
20 1984)). Deciding whether "exceptional circumstances" exist requires an evaluation of the likelihood
21 of plaintiff's success on the merits as well as the ability of the plaintiff to articulate her claims *pro se*
22 in light of the complexity of the legal issues. *Wilborn v. Escalderon*, 789 F.2d 1328, 1331 (9th Cir.
23 1986) (citing *Weygandt v. Look*, 718 F.2d 952, 954 (9th Cir. 1983)).

24 At this stage of the proceedings, where Plaintiff's complaint has been dismissed and there is
25 no operative complaint on file, the Court is unable to determine whether the exceptional
26 circumstances required for requesting counsel are present here. Accordingly, Plaintiff's Motion for
27 Appointment of Counsel is **DENIED WITHOUT PREJUDICE**. The Court may reconsider on its own
28 motion and request appointment of counsel later in the proceedings.
