WHEREAS Plaintiff Vallie Towns' has filed, by stipulation of the parties, a First Amended Complaint which omits all federal claims against all defendants;

4 Complaint in the Superior Court of the State of California, County of Alameda after  
5 remand is complete by the date set by the Superior Court judge assigned to the case.
