

1	STANDING ORDER FOR ALL JUDGES OF THE NORTHERN DISTRICT OF
2	CALIFORNIA
3	CONTENTS OF JOINT CASE MANAGEMENT STATEMENT
4	
5	Commencing March 1, 2007, all judges of the Northern District of California will require the identical information in Joint Case Management Statements filed pursuant to
6	Civil Local Rule 16-9. The parties must include the following information in their statement
7	which, except in unusually complex cases, should not exceed ten pages:
8	1. <u>Jurisdiction and Service</u> : The basis for the court's subject matter jurisdiction over
9	plaintiff's claims and defendant's counterclaims, whether any issues exist regarding
10	personal jurisdiction or venue, whether any parties remain to be served, and, if any parties
11	remain to be served, a proposed deadline for service.
12	2. <u>Facts</u> : A brief chronology of the facts and a statement of the principal factual
13	issues in dispute.
14	3. <u>Legal Issues</u> : A brief statement, without extended legal argument, of the disputed
15	points
16	of law, including reference to specific statutes and decisions.
17	4. <u>Motions</u> : All prior and pending motions, their current status, and any anticipated
18 10	motions.
19 20	5. <u>Amendment of Pleadings</u> : The extent to which parties, claims, or defenses are
20 21	expected to be added or dismissed and a proposed deadline for amending the pleadings.
21 22	6. <u>Evidence Preservation</u> : Steps taken to preserve evidence relevant to the issues
22	reasonably evident in this action, including interdiction of any document-destruction
23 24	program and any ongoing erasures of e-mails, voice mails, and other electronically-

26	7. <u>Disclosures</u> : Whether there has been full and timely compliance with the initial
27	disclosure requirements of Fed. R. Civ. P. 26 and a description of the disclosures mad

1 2 3	8. <u>Discovery</u> : Discovery taken to date, if any, the scope of anticipated discovery, any proposed limitations or modifications of the discovery rules, and a proposed discovery plan pursuant to Fed. R. Civ. P. 26(f).
4 5	9. <u>Class Actions</u> : If a class action, a proposal for how and when the class will be certified.
6 7	10. <u>Related Cases</u> : Any related cases or proceedings pending before another judge of this court, or before another court or administrative body.
8 9 10 11	11. <u>Relief</u> : All relief sought through complaint or counterclaim, including the amount of any damages sought and a description of the bases on which damages are calculated. In addition, any party from whom damages are sought must describe the bases on which it contends damages should be calculated if liability is established.
12 13 14	12. <u>Settlement and ADR</u> : Prospects for settlement, ADR efforts to date, and a specific ADR plan for the case, including compliance with ADR L.R. 3-5 and a description of key discovery or motions necessary to position the parties to negotiate a resolution.
15 16 17	13. <u>Consent to Magistrate Judge For All Purposes</u> : Whether all parties will consent to have a magistrate judge conduct all further proceedings including trial and entry of judgment.
18 19	14. <u>Other References</u> : Whether the case is suitable for reference to binding arbitration, a special master, or the Judicial Panel on Multidistrict Litigation.
20 21 22	15. <u>Narrowing of Issues</u> : Issues that can be narrowed by agreement or by motion, suggestions to expedite the presentation of evidence at trial (e.g., through summaries or stipulated facts), and any request to bifurcate issues, claims, or defenses.
23 24 25	16. <u>Expedited Schedule</u> : Whether this is the type of case that can be handled on an expedited basis with streamlined procedures.
25 26 27	17. <u>Scheduling</u> : Proposed dates for designation of experts, discovery cutoff, hearing of dispositive motions, pretrial conference and trial.
28	18. <u>Trial</u> : Whether the case will be tried to a jury or to the court and the expected length of the trial.

1	19. <u>Disclosure of Non-party Interested Entities or Persons</u> : Whether each party has filed
2	the "Certification of Interested Entities or Persons" required by Civil Local Rule 3-16. In
3	<b>addition</b> , each party must restate in the case management statement the contents of its certification by identifying any persons, firms, partnerships, corporations (including parent
4	corporations) or other entities known by the party to have either: (i) a financial interest in
5	the subject matter in controversy or in a party to the proceeding; or (ii) any other kind of
6	interest that could be substantially affected by the outcome of the proceeding.
7 8	20. Such other matters as may facilitate the just, speedy and inexpensive disposition of this matter.
9	IT IS SO ORDERED.
