20 PLEASE TAKE NOTICE that pursuant to F.R.C.P., Rule 41(a)(1), Plaintiffs
 21 NORTHERN CALIFORNIA GLAZIERS, ARCHITECTURAL METAL AND GLASS
 22 WORKERS PENSION PLAN, et al., voluntarily dismiss, without prejudice, their claim against
 23 Defendant MARY TAUSHECK only.

24 Defendant Mary Tausheck has not served an Answer or otherwise appeared in this matter,
 25 and Plaintiffs have not previously filed or dismissed any similar action against Defendant Mary
