DIRECTING CLERK
OF THE COURT TO TERMINATE ALL
PENDING MOTIONS

10 Petitioner, a state prisoner, filed the present pro se
11 petitions for a writ of habeas corpus pursuant to 28 U.S.C. § 2254,
12 challenging his 1998 conviction for attempted murder. Petitioner
13 previously challenged the same conviction in a habeas petition that
14 was denied on the merits. See Ellis v. Roe, Case No. C 01-3141 MMC
15 (PR). Since that denial, this Court has denied, under 28 U.S.C.
16 § 2244, Petitioner's previous attempt to present a renewed
17 challenge to his conviction without prior approval from the Ninth
18 Circuit. See Ellis v. Hill, Case No. C 09-00351 CW (PR).
19 Specifically, a second or successive petition containing previously
20 raised or new claims may not be filed in the district court unless
21 the petitioner first obtains from the United States Court of
22 Appeals an order authorizing the district court to consider the
23 petition. 28 U.S.C. § 2244(b)(3)(A).

24 Because Petitioner here has not obtained prior approval from
25 the Ninth Circuit for this Court to consider his renewed challenge
26 to his conviction in the above-titled petitions, the petitions are
27 DISMISSED without prejudice to Petitioner's filing a petition in

1 this Court if he obtains the necessary order from the Ninth
2 Circuit.¹

3 In light of Petitioner's lack of funds, his applications to
4 proceed in forma pauperis are GRANTED.

5 CONCLUSION

6 For the reasons stated above, the above-titled petitions are
7 DISMISSED without prejudice.

8 Petitioner's applications to proceed in forma pauperis are
9 GRANTED.

10 The Clerk of the Court shall terminate all pending motions in
11 the present actions, enter judgment and close the files.

12 This Order terminates Docket nos. 2 and 3 in Case no. C 11-
13 05121 CW (PR), and Docket nos. 2 and 3 in Case no. C 11-05389.

14 IT IS SO ORDERED.

26 See Felker v. Turpin, 518 U.S. 651, 662 (1996). Petitioner still may
file an original successive habeas petition in the United States
27 Supreme Court, in which case the court of appeals' permission to file
is not needed. See id. at 660-61.
