1 hearing on Friday, October 25, 2013 at 9:01 a.m. is intended to confirm that counsel have timely met
2 and conferred as required by the Pretrial Instructions. The compliance hearing shall be held in the
3 Federal Courthouse, 1301 Clay Street, Oakland, California, in Courtroom 5. Five (5) business days
4 prior to the date of the compliance hearing, the parties shall file a one-page JOINT STATEMENT
5 confirming they have complied with this requirement or explaining their failure to comply. If
6 compliance is complete, the parties need not appear and the compliance hearing will be taken off
7 calendar. Telephonic appearances will be allowed if the parties have submitted a joint statement in a
8 timely fashion. Failure to do so may result in sanctions.

9 The parties must comply with both the Court's Standing Order in Civil Cases and Standing
10 Order for Pretrial Instructions in Civil Cases for additional deadlines and procedures. All Standing
