1 Based on Plaintiff Janelle Jasso's ("Plaintiff") Request for Dismissal and the  
2 Declaration of Kitty K. Szeto in Support Thereof, and for good cause shown,

3 **IT IS HEREBY ORDERED THAT:**

4 1. Plaintiff's individual claims are hereby dismissed with prejudice.

5 2. The absent class members' claims against Defendants Money Mart Express,  
6 Inc. and Dollar Financial Group, Inc. are hereby dismissed without prejudice and without  
7 notice to the unnamed putative class members. Such dismissal is without prejudice as to  
8 any parties who may file claims similar to those alleged in Plaintiff's Complaint.

9 3. The dismissal of this case will have no collateral estoppel or *res judicata*  
10 effect on any similar claims brought by any other persons, including claims identical or  
11 substantially similar to Plaintiff's claims in this case.

12 4. Each party shall bear her/its own attorneys' fees and costs incurred in  
13 connection with this matter.
