ORDER RETURNING  
COMPLAINT TO  
PLAINTIFF

12 On December 9, 2005, this Court entered a pre-filing order  
13 regarding the cases filed by Plaintiff Jerome Grimes. The pre-  
14 filing order states that if Plaintiff files a complaint that is  
15 "related to any of the following matters:

- 16 (1) a diversified group of individuals who commit acts  
17 of terror against Mr. Grimes, his family and  
18 other citizens;
- 19 (2) an injunction against the defendants to prevent them from  
20 kidnaping, framing, falsely imprisoning or otherwise  
21 terrorizing Mr. Grimes, his family, and other citizens;
- 22 (3) a court order for the defendants to be subjected to a lie  
detector test;
- 23 (4) covert terrorism

24 it will not be filed unless it presents cognizable claims that are  
25 not based on merely conclusory allegations. Second, no other  
26 complaints filed by Mr. Grimes while he is not incarcerated or  
27 detained will be filed unless they contain intelligible factual  
allegations and claims for relief."

28 The Court has reviewed the instant complaint, C 11-80011M, and

1 finds that it alleges that Defendants have engaged in terrorism  
2 against Plaintiff and engaged in many other heinous acts. Because  
3 this complaint concerns several of the matters mentioned in the  
4 pre-filing order, the Clerk of the Court is ordered not to file it.  
5 Instead, the complaint shall be returned to Plaintiff.  
6 IT IS SO ORDERED.
