[PROPOSED] ORDER FOLLOWING APRIL 9, 2013 STATUS CONFERENCE

1 The Court held a status conference on April 9, 2013. Counsel for Plaintiff Oracle  
2 America, Inc. (“Oracle”), and Defendants DLT Federal Business Systems Corporation (“DLT-  
3 FBS” or “FBSC”), Service Key LLC and Angela Vines appeared. At the status conference, the  
4 Court ordered as follows:

5 1. The depositions of Geoff Prosser, Rose Osamba and Robert Wright that are  
6 scheduled for April 23, 24 and 25, 2013, shall be conducted at defense counsel’s offices at 8300
