



1) This Court has jurisdiction over the parties to this action and over the subject matter hereof pursuant to 17 U.S.C. § 101 et seq., 15 U.S.C. § 1051 et seq., 28 U.S.C. §§ 1331 and 1338, and 28 U.S.C. § 1367. Service of process was properly made against Defendant.

2) Plaintiffs are the owners or exclusive licensees of all rights in and to the copyright and trademark registrations listed in Exhibits “A” through “H,” attached hereto and incorporated herein by this reference, and the copyrights associated with the same (“Plaintiffs’ Properties”).

3) Plaintiffs have expended considerable resources in the creation and commercial exploitation of Plaintiffs’ Properties on merchandise and in the enforcement of its intellectual property rights in Plaintiffs’ Properties.

4) Plaintiffs have alleged that Defendant has made unauthorized uses of Plaintiffs’ Properties or substantially similar likenesses or colorable imitations thereof.

5) Defendant and his agents, servants, employees and all persons in active concert and participation with him who receive actual notice of the injunction are hereby restrained and enjoined from:

a) Infringing Plaintiffs’ copyrights and trademarks in Plaintiffs’ Properties, either directly or contributorily, in any manner, including generally, but not limited to manufacturing, importing, distributing, advertising, selling, offering for sale, renting, or offering to rent any unauthorized product which features any of Plaintiffs’ Properties (“Unauthorized Products”), and, specifically:

- i) Importing, manufacturing, distributing, advertising, selling, renting, offering to rent, or offering for sale, the Unauthorized Products or any other unauthorized products which picture, reproduce, copy or use the likenesses of or bear a substantial similarity to any of Plaintiffs’ Properties;
- ii) Importing, manufacturing, distributing, advertising, selling, offering for sale, renting or offering to rent in connection thereto any unauthorized promotional materials, labels, packaging or containers which picture, reproduce, copy or use the likenesses of or bear a confusing similarity to any of Plaintiffs’ Properties;
- iii) Engaging in any conduct that tends falsely to represent that, or is likely to confuse, mislead or deceive purchasers, Defendant’s customers and/or members of the public to believe, the actions of Defendant, the products sold or offered by Defendant, or Defendant himself is connected with Plaintiffs, is sponsored, approved or licensed by Plaintiffs, or is affiliated with Plaintiffs; or

1 iv) Affixing, applying, annexing or using in connection with the importation,  
2 manufacture, distribution, advertising, selling, offering for sale, or other use of  
3 any goods or services, a false description or representation, including words or  
4 other symbols, tending to falsely describe or represent such goods as being those  
5 of Plaintiffs.

- 6 6) Each side shall bear its own fees and costs of suit.  
7 7) This Consent Decree shall be deemed to have been served upon Defendant at the time of its  
8 execution by the Court.  
9 8) The Court finds there is no just reason for delay in entering this Consent Decree and,  
10 pursuant to Rule 54(a) of the Federal Rules of Civil Procedure, the Court directs immediate  
11 entry of this Consent Decree against Defendant.  
12 9) The Court shall retain jurisdiction of this action to entertain such further proceedings and to  
13 enter such further orders as may be necessary or appropriate to implement and enforce the  
14 provisions of this Consent Decree.  
15 10) Except as provided herein, all claims alleged in the Complaint are dismissed with prejudice.
