1 Pursuant to the Court's Pretrial Instructions in Civil Cases at Section 2, trial counsel shall meet
2 and confer at least twenty-one (21) days in advance of the Pretrial Conference. The compliance
3 hearing on Friday, December 13, 2013 at 9:01 a.m. is intended to confirm that counsel have timely
4 met and conferred as required by the Pretrial Instructions. The compliance hearing shall be held in the
5 Federal Courthouse, 1301 Clay Street, Oakland, California, in Courtroom 5. Five (5) business days
6 prior to the date of the compliance hearing, the parties shall file a one-page JOINT STATEMENT
7 confirming they have complied with this requirement or explaining their failure to comply. If
8 compliance is complete, the parties need not appear and the compliance hearing will be taken off
9 calendar. Telephonic appearances will be allowed if the parties have submitted a joint statement in a
10 timely fashion. Failure to do so may result in sanctions.

11 As set forth above, the parties are REFERRED to private mediation. The parties shall provide
12 the Court with the name of an agreed-upon mediator by November 16, 2012 by filing a JOINT Notice
13 A compliance hearing regarding shall be held on Friday, November 30, 2012 on the Court's 9:01 a.m.
14 calendar, in the Federal Courthouse, 1301 Clay Street, Oakland, California, in a courtroom to be
15 designated. By November 16, 2012, the parties shall file either the JOINT Notice or a one-page
16 JOINT STATEMENT setting forth an explanation for their failure to comply. If compliance is
17 complete, the parties need not appear and the compliance hearing will be taken off calendar.
18 Telephonic appearances will be allowed if the parties have submitted a joint statement in a timely
19 fashion.

20 The parties must comply with both the Court's Standing Order in Civil Cases and Standing
21 Order for Pretrial Instructions in Civil Cases for additional deadlines and procedures. All Standing
