19 IT IS STIPULATED by and between plaintiff Andrew P. Zutis (“Plaintiff”) and defendant
 20 Michael J. Astrue, Commissioner of Social Security (“Defendant”), through their undersigned counsel
 21 of record, that the above-entitled action shall be remanded to the Commissioner of Social Security for
 22 further administrative proceedings.

23 Upon remand, the Office of Disability Adjudication and Review will remand the case to an
 24 Administrative Law Judge (ALJ), who will offer Plaintiff an opportunity for a hearing, reconsider the
 25 medical source opinions offered by Dr. Pont and provide specific and legitimate reasons if rejecting any
 26 of the opinions in accordance with Social Security Ruling 96-2p; obtain if necessary, medical expert
 27


1 testimony to assist in determining the onset date of disability. This stipulation constitutes a remand
2 under the fourth sentence of Section 205(g) of the Social Security Act, 42 U.S.C. 405(g).
