3 suffered gunshot wounds on September 17, 2011 as an innocent bystander to a police action
4 being undertaken by officers from the San Francisco Police Department;

6 2. Plaintiff Jose Garcia filed the above civil rights action in which he alleges he
7 suffered gunshot wounds as an innocent bystander during the same police action;

8 3. Both actions have been referred to Magistrate Judge Donna M. Ryu for settlement
9 conference;

10 4. Both actions involve the same facts and applicable law and differ only in the nature
11 and extent of their respective claims for damages;


