12 TO ALL PARTIES AND COUNSEL OF RECORD:

13 The above matter having been reassigned to the Honorable Phyllis J. Hamilton. It is
14 hereby ordered, pursuant to Fed. R. Civ. P. 16(b) and Civil L. R. 16-10, that a Case
15 Management Conference shall be held in this case on **September 6, 2012**, at 2:00 p.m., in
16 Courtroom 3, 3rd Floor, Federal Building, 1301 Clay Street, Oakland, California.

17 Counsel shall meet and confer as required by Fed. R. Civ. P. 26(f) prior to the Case
18 Management Conference with respect to those subjects set forth in Fed. R. Civ. P. 16(c).
19 **Not less than seven (7) days** before the conference, counsel shall file a joint case
20 management statement addressing each of the items listed in the "Standing Order For All
21 Judges of the Northern District -- Contents of Joint Case Management statement," which is
22 attached to this order and can also be found on the court's website. A proposed order is
23 not necessary. Following the conference, the court will enter its own Case Management
24 and Pretrial Order. If any party is proceeding without counsel, separate statements may be
25 filed by each party.

26 Each party shall appear personally or by counsel prepared to address all of the
27 matters referred to in this Order and with authority to enter stipulations and make
28 admissions pursuant to this Order. Any request to reschedule the date of the conference
shall be made in writing, and by stipulation if possible, at least ten (10) days before the
date of the conference and must be based upon good cause.

1 **STANDING ORDER FOR ALL JUDGES OF THE NORTHERN DISTRICT OF**
2 **CALIFORNIA**

3 **CONTENTS OF JOINT CASE MANAGEMENT STATEMENT**
4

5 Commencing July 1, 2011, all judges of the Northern District of California will require
6 the identical information in Joint Case Management Statements filed pursuant to Civil Local
7 Rule 16-9. The parties must include the following information in their statement which,
8 except in unusually complex cases, should not exceed ten pages:

9 1. Jurisdiction and Service: The basis for the court’s subject matter jurisdiction over
10 plaintiff’s claims and defendant’s counterclaims, whether any issues exist regarding
11 personal jurisdiction or venue, whether any parties remain to be served, and, if any parties
12 remain to be served, a proposed deadline for service.

13 2. Facts: A brief chronology of the facts and a statement of the principal factual
14 issues in dispute.

15 3. Legal Issues: A brief statement, without extended legal argument, of the disputed
16 points of law, including reference to specific statutes and decisions.

17 4. Motions: All prior and pending motions, their current status, and any anticipated
18 motions.

19 5. Amendment of Pleadings: The extent to which parties, claims, or defenses are
20 expected to be added or dismissed and a proposed deadline for amending the pleadings.

21 6. Evidence Preservation: Steps taken to preserve evidence relevant to the issues
22 reasonably evident in this action, including interdiction of any document-destruction
23 program and any ongoing erasures of e-mails, voice mails, and other electronically
24 recorded material.

25 7. Disclosures: Whether there has been full and timely compliance with the initial
26 disclosure requirements of Fed. R. Civ. P. 26 and a description of the disclosures made.

27 8. Discovery: Discovery taken to date, if any, the scope of anticipated discovery, any
28 proposed limitations or modifications of the discovery rules, and a proposed discovery plan
pursuant to Fed. R. Civ. P. 26(f).

- 1 9. Class Actions: If a class action, a proposal for how and when the class will be
2 certified.
- 3 10. Related Cases: Any related cases or proceedings pending before another judge of
4 this court, or before another court or administrative body.
- 5 11. Relief: All relief sought through complaint or counterclaim, including the amount of
6 any damages sought and a description of the bases on which damages are calculated. In
7 addition, any party from whom damages are sought must describe the bases on which it
8 contends damages should be calculated if liability is established.
- 9 12. Settlement and ADR: Prospects for settlement, ADR efforts to date, and a specific
10 ADR plan for the case, including compliance with ADR L.R. 3-5 and a description of key
11 discovery or motions necessary to position the parties to negotiate a resolution.
- 12 13. Consent to Magistrate Judge For All Purposes: Whether **all** parties will consent to
13 have a magistrate judge conduct all further proceedings including trial and entry of
14 judgment. ____Yes ____No
- 15 14. Other References: Whether the case is suitable for reference to binding arbitration, a
16 special master, or the Judicial Panel on Multidistrict Litigation.
- 17 15. Narrowing of Issues: Issues that can be narrowed by agreement or by motion,
18 suggestions to expedite the presentation of evidence at trial (e.g., through summaries or
19 stipulated facts), and any request to bifurcate issues, claims, or defenses.
- 20 16. Expedited Trial Procedure: Whether this is the type of case that can be handled
21 under the Expedited Trial Procedure of General Order No. 64 Attachment A. If all parties
22 agree, they shall instead of this Statement, file an executed Agreement for Expedited Trial
23 and a Joint Expedited Case Management Statement, in accordance with General Order
24 No. 64 Attachments B and D.
- 25 17. Scheduling: Proposed dates for designation of experts, discovery cutoff, hearing of
26 dispositive motions, pretrial conference and trial.
- 27 18. Trial: Whether the case will be tried to a jury or to the court and the expected length
28 of the trial.

1 19. Disclosure of Non-party Interested Entities or Persons: Whether each party has filed
2 the "Certification of Interested Entities or Persons" required by Civil Local Rule 3-16. **In**
3 **addition**, each party must restate in the case management statement the contents of its
4 certification by identifying any persons, firms, partnerships, corporations (including parent
5 corporations) or other entities known by the party to have either: (i) a financial interest in
6 the subject matter in controversy or in a party to the proceeding; or (ii) any other kind of
7 interest that could be substantially affected by the outcome of the proceeding.

8 20. Such other matters as may facilitate the just, speedy and inexpensive disposition of
9 this matter.
