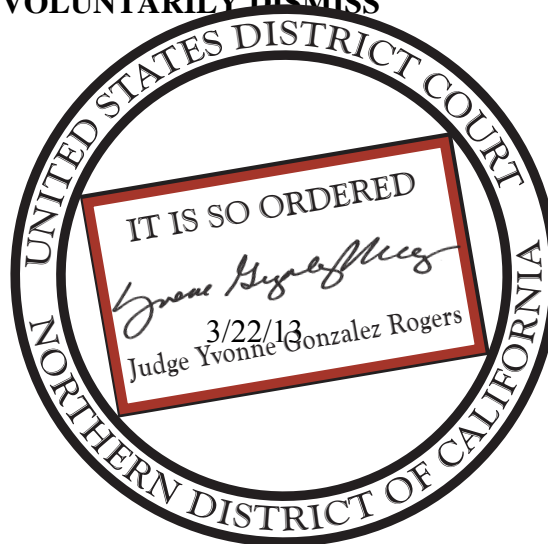

Pursuant to Fed R. Civ. Proc. 41(a)(1)(A)(ii), Plaintiff MT. LOOKOUT
