15		Cornelius shall not have to sit for an expert deposition in this action.	
16	5.	No party shall offer into evidence or mention in any argument that Dr.	
17		Gershony or Mr. Cornelius submitted an expert report in this action, that said	
18		expert reports were withdrawn, and/or the existence or terms of this	
19	Stipulation, except in a motion outside the hearing of the jury to enforce this		
20	Stipulation.		
21	6.	Mr. Horzewski will not rely on the Expert Reports of Gary Gershony, M.D.	
22		or Rajendra Cornelius as bases for his opinions, and will not testify at trial	
23		concerning the content of those Expert Reports or any discussions with Dr.	
24		Gershony or Mr. Cornelius concerning the content of those Expert Reports.	
25	7.	Except as set forth in Paragraph 3, this Stipulation and the withdrawal of the	
26		Expert Report of Gary Gershony, M.D. shall have no effect on Dr.	
27		Gershony's ability to testify as a fact witness in this action or the scope of	
28		that fact testimony. Similarly, this Stipulation and the withdrawal of the
