25 and/or assets held in any way on behalf of or for the benefit of Clarus, and documents
26 relating to any recent and/or pending investments in the company.

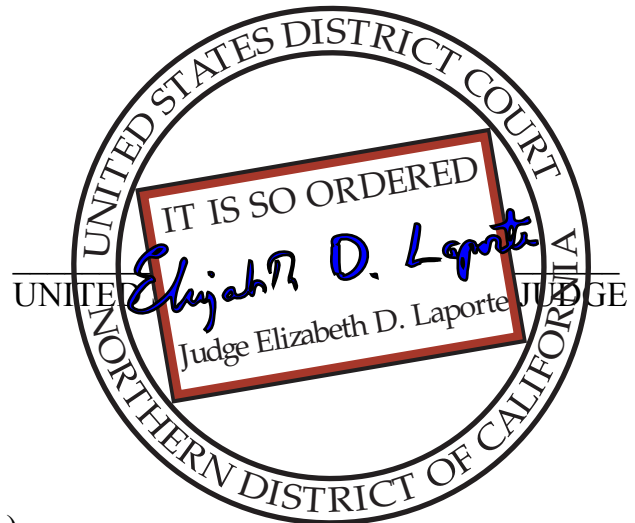
