Plaintiff and 20 Defendants' counsel shall participate in a telephone conference, to be scheduled by the ADR Unit by 21 September 4, 2012 or as soon thereafter as is convenient to the ADR Unit. 22 Plaintiff and Defendants' counsel shall be prepared to discuss the following subjects: 23 Identification and description of claims and alleged defects in loan (1) 24 documents. 25 (2) Prospects for loan modification. 26 Prospects for settlement. (3) 27 The parties need not submit written materials to the ADR Unit for the telephone conference. 28 In preparation for the telephone conference, Plaintiff shall do the following:

1	(1)	Review relevant loan documents and investigate the claims to determine whether they have merit.
2	(2)	If Plaintiff is seeking a loan modification to resolve all or some of the claims,
3	(2)	Plaintiff shall prepare a current, accurate financial statement and gather all of the information and documents customarily needed to support a loan
4		modification request. Further, Plaintiff shall immediately notify Defendants' counsel of the request for a loan modification.
5 6	(3)	Provide counsel for Defendants with information necessary to evaluate the prospects for loan modification, in the form of a financial statement,
7	worksheet or application customarily used by financial institutions.	
8	In preparation for the telephone conference, counsel for Defendants shall do the following.	
9	(1)	If Defendants are unable or unwilling to do a loan modification after receiving notice of Plaintiff's request, counsel for Defendants shall promptly notify
10		Plaintiff to that effect.
11	(2)	Arrange for a representative of each Defendant with full settlement authority to participate in the telephone conference.
12	The ADR Unit will notify the parties of the date and time the telephone conference will be	
13	held. After the telephone conference, the ADR Unit will advise the court of its recommendation for	
14	further ADR proceedings.	
15	Upon receipt of this order, Plaintiffs shall serve Defendants with a copy and file a proof of	
16	service with the Court.
