1 Defendants (“Dollar”) and Plaintiffs (collectively, the “Parties”) file this joint stipulation
2 pursuant to Fed. R. Civ. P. 16(b)(4); and Civil L.R. 7-12, 6-1(b), and 6-2 to request that the Court:
3 (1) continue the date of the Case Management Conference and hearing on the pending motion for
4 class certification so that both matters are heard on the same date, as set forth below, and (2) modify
5 the deadline for filing the reply brief related to Plaintiffs’ Amended Motion for Class Certification as
6 set forth below.
7

8 1. **Case Management Conference Date.** On December 4, 2015, the Court entered a
9 Case Management Scheduling Order, providing for a Case Management Conference on February
10 22, 2016 at 2 p.m. (ECF No. 151.) The Parties jointly request, for the reasons set forth in the
11 attached declaration of Alan M. Mansfield, that the Court amend the Case Management Scheduling
12 Order to set the Case Management Conference as the same date as the hearing on the pending
13 motion for class certification.

15 2. **Briefing and Hearing Schedule on Class Certification Motion.** On November 18,
16 2015, the Court granted the Parties’ motion to amend the briefing and hearing schedule for
17 Plaintiffs’ Amended Motion for Class Certification (“Amended Motion”). (ECF No. 147.) Under
18 the current briefing schedule, Plaintiffs’ Reply papers in support of the Amended Motion are due by
19 January 12, 2016, and the hearing on the motion is set for February 9, 2016. As set forth in the
20 Declaration of Alan M. Mansfield, in connection with their Opposition Dollar submitted the
21 Declarations of several individuals, including three Dollar employees in Southern California. Based
22 on negotiations between counsel for the parties, depositions of those Declarants have just recently
23 been set for January 14, 2016. As a result, the parties are in agreement to move the deadline for
24 Plaintiffs to file the reply brief for two weeks, until January 26, 2016, and continue the hearing date
25 on the motion for class certification to February 22, 2016, the present date as the Case Management
26 Conference.

1 If the Court prefers to hold a hearing on this motion on February 23, 2016 on its regular
2 motion calendar date, the parties would request the Case Management Conference be continued to
3 take place on that date.
