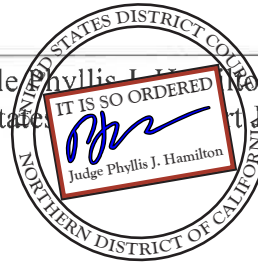
The Court, having considered the Parties' Joint Status Report, and good cause appearing thereon, hereby **ORDERS** as follows:
