| 19 | Cir. 1996) (courts have discretion to strike oversized briefs). Accordingly, | |

| 21 | 1. Plaintiff's Application for Default Judgment by the Court (Dkt. 26), including | |
| 22 | all supporting documents, shall be STRICKEN from the record. | |
| 23 | 2. By no later than July 18, 2013, Plaintiff shall refile its Application for Default | |
| 24 | Judgment by the Court which is compliant with the Court's Standing Orders. Upon filing, | |
| 25 | such motion shall be REFERRED to Magistrate Judge Joseph Spero for a report and | |
| 26 | recommendation. Said renewed application shall be filed and noticed in a manner | |
| 27 | consistent with Magistrate Judge Spero's Standing Orders. | |
