24 Plaintiff GE CAPITAL INFORMATION TECHNOLOGY SOLUTIONS INC., a corporation,  
 fdba IKON FINANCIAL SERVICES (hereinafter referred to as "Plaintiff"), and Defendant CAROL H.  
 25 WILLIAMS ADVERTISING, a California corporation (hereinafter referred to as "Defendant"), hereby  
 26 stipulate as follows:

- 27 1. On December 14, 2012, Plaintiff commenced an action in the Superior Court of

1 California, County of Alameda, Case Number RG12-659845, entitled GE CAPITAL INFORMATION  
2 TECHNOLOGY SOLUTIONS, INC., fdba IKON FINANCIAL SERVICES, Plaintiff v. CAROL H  
3 WILLIAMS, a California corporation; Does 1-100, Defendants (the "Action").

4 2. On February 12, 2013, Defendant filed a Notice of Removal of the Action, pursuant to  
5 28 U.S.C. §§1441 and 1446, to the United States District Court, Northern District of California.

6 3. On December 5, 2013, the Parties reached a complete settlement of their dispute at  
7 Court ordered Mediation and are currently finalizing a Settlement Agreement, which provides that the  
8 settlement shall be governed by California Code of Civil Procedure §664.6. On December 9, 2013,  
9 Mediator Robert Ebbe filed a Certification of ADR Session, stating that this case was fully settled at  
10 Mediation.

11 4. Pursuant to the Settlement Agreement, Plaintiff and Defendant now agree and stipulate  
12 that the Action should be remanded to the Superior Court of California, County of Alameda (Case  
13 Number RG12-659845).

14 5. Plaintiff and Defendant further stipulate that each party shall bear its own attorney's fees  
15 and costs with respect to the remand of the Action pursuant to this Stipulation and Order.
