ORDER 1 On December 4, 2015, this Court conducted a hearing on Plaintiffs' Motion for Preliminary 2 3 Approval of the Class Action Settlement (the "Motion"). Having considered the Motion and the points and authorities and declarations submitted in support of the Motion, including the Joint Stipulation of 4 5 Class Action Settlement and Release ("Settlement Agreement" or "Settlement") and exhibits, and GOOD CAUSE appearing, IT IS HEREBY ORDERED that the Motion is GRANTED, subject to 6 the following findings and orders: 7 8 1. This Order incorporates by reference the definitions in the Settlement Agreement, and 9 all terms defined therein shall have the same meaning as set forth in the Settlement Agreement. 2. 10 The Settlement Class shall be conditionally certified for settlement purposes only and 11 shall consist of all persons who were employed at Anthropologie stores in California as hourly managers 12 or hourly supervisors (i.e., Operations Supervisors, Selling Supervisors, or Managers in Training) at any 13 time during the period from April 10, 2009 to the date of preliminary approval. 14 3. The class action settlement set forth in the Settlement Agreement, entered into among 15 the Parties and their counsel, is preliminarily approved as it appears to be proper, to fall within the range 16 of reasonableness, to be the product of arm's-length and informed negotiations, to treat all Class 17 Members fairly, and to be presumptively valid, subject only to any objections that may be raised at or 18 before the final approval hearing. The Court further finds that Plaintiffs' counsel conducted extensive 19 investigation and research, and that they were able to reasonably evaluate Plaintiffs' position and the 20 strengths and weaknesses of their claims and the ability to certify them. Plaintiffs have provided the 21 Court with enough information about the nature and magnitude of the claims being settled, as well as the 22 impediments to recovery, to make an independent assessment of the reasonableness of the terms to

23 which the parties have agreed.

4. The Court also finds that settlement now will avoid additional and potentially substantial
litigation costs, as well as delay and risks if the Parties were to continue to litigate the Action.

5. The Court preliminarily approves the Settlement Agreement, including all the terms and
conditions set forth therein and the Class Settlement Amount and allocation of payments.

The rights of any potential dissenters to the proposed Settlement are adequately

1	protected in that they may exclude themselves from the Settlement and proceed with any alleged claims		
2	they may have against Defendant, or they may object to the Settlement and appear before this Court.		
3	However, to do so they must follow the procedures outlined in the Settlement Agreement and Notice of		
4	Class Action Settlement. Failure to follow the procedures outlined in the Settlement Agreement and		
5	Notice of Class Action Settlement for making objections shall result in waiver and the objector shall be		
6	forever foreclosed from challenging any of the terms of the Settlement.		
7	7. The Court approves, as to form and content, the proposed Notice of Class Action		
8	Settlement ("Class Notice").		
9	8. The Court directs the mailing, by First-Class U.S. mail, of the Class Notice to Class		
10	Members in accordance with the schedule set forth below and the other procedures described in the		
11	Settlement Agreement. The Court finds that the method selected for communicating the preliminary		
12	approval of the Settlement Agreement to Class Members is the best notice practicable under the		
13	circumstances, constitutes due and sufficient notice to all persons entitled to notice, and thereby satisfies		
14	due process.		
15	9. The named Plaintiffs Alexander Moore and Charlotte Whitmore are suitable class		
16	representatives and are appointed Class Representatives for the Settlement Class conditionally certified		
17	by this Order.		
18	10. The Court appoints Capstone Law APC as Class Counsel. The Court finds that counsel		
19	have demonstrable experience litigating, certifying, and settling class actions, and will serve as adequate		
20	counsel for the Class conditionally certified by this Order.		
21	11. The Court approves and appoints Simpluris, Inc. as the Settlement Administrator.		
22	12. The following dates shall govern for purposes of this Settlement:
