8 c. Rebuttal experts shall be disclosed and reports provided by **February 13, 2015**.
9 d. All discovery from experts shall be completed by **February 27, 2015**.

10 3. PRE-TRIAL MOTIONS

- 11 a. The last day for hearing dispositive motions shall be **December 18, 2014**.
12 All other provisions of the Amended Case Management and Pre-Trial Order remain the
13 same.

15 In addition to these modifications, the parties have agreed to a briefing schedule for
16 defendant's motion for summary judgment or partial summary judgment, as follows:

- 17 a. The motion will be filed by October 30, 2014.
18 b. The Opposition will be filed by November 21, 2014.
19 c. The reply will be filed by December 5, 2014.
