**JOINT STIPULATION TO CONTINUE
 CASE MANAGEMENT CONFERENCE;
~~PROPOSED ORDER~~**

Complaint filed: January 31, 2014

1 Pursuant to Northern District Local Rule 16-2(d) and (e) and Rule 7-12, plaintiff SAN
2 JOSE OPTIONS INC. (“Plaintiff”) and defendant HO CHUNG YEH (“Defendant”), by and
3 through their counsel of record, stipulate as follows:

4 **RECITALS**

5 1. On October 29, 2014 [docket 39], this Court continued the Case Management
6 Conference to March 17, 2015, so that the parties could pursue potential resolution of this matter
7 through alternative dispute resolution rather than incurring additional fees and costs on litigation;

8 2. On February 26, 2015 [docket 44], the Northern District appointed the Hon.
9 Suzanne Nusbaum as mediator in this matter;

10 3. On March 5, 2015, Judge Nusbaum conducted an initial conference call with
11 counsel for the parties wherein the parties, among other things, agreed to mediate the case on
12 March 17, 2015, beginning at 9:00 a.m. in San Mateo, California. The parties agreed to mediate
13 on that date since Defendant had to be out of the United States for approximately 60 to 75 days
14 beginning on March 20, 2015;

15 4. On March 6, 2015, Judge Nusbaum informed counsel for the parties that she
16 needed to canceled the March 17, 2015 mediation due to a death in her family;

17 5. Later on March 6, 2015, Judge Nusbaum provided the parties with additional
18 mediation dates, including June 12, 2015;

19 6. On March 10, 2015, Defendant’s counsel notified Judge Nusbaum that Defendant
20 was available to mediate the case on June 12, 2015;

21 7. On March 11, 2015, Plaintiff’s counsel notified Judge Nusbaum that Plaintiff was
22 available to mediate the case on June 12, 2015;

23 8. On March 12, 2015, Judge Nusbaum informed counsel for the parties that she was
24 no longer available on June 12, 2015 for mediation and provided the following alternative dates in
25 the month of June: 4, 5, 22, 24, 25, 26, 29 or 30;

26 9. On March 13, 2015, counsel for Plaintiff and Defendant notified Judge Nusbaum
27 that both parties were available to mediate the case on June 22 or June 24, 2015;

28 10. Also, on March 13, 2015, Judge Nusbaum confirmed the mediation date of June 22,

1 2015, to be conducted at Plaintiff's counsel's office.

2 11. Plaintiff and Defendant want to try to mediate this case first before either side
3 incurs significant litigation fees and costs;

4 12. Counsel for Defendant is scheduled to commence a five day trial in Southern
5 California on July 6, 2015;

6 13. Given that (a) the parties are still trying to set a mediation date for June of 2015 but
7 have been unable to due to no fault of their own, (b) are working with Judge Nusbaum and her
8 calendar to set a mediation date as soon as possible, (c) it remains unlikely that mediation will be
9 completed in this matter until the end of June of 2015, counsel for Plaintiff and Defendant would
10 respectfully request that the Case Management Conference be continued to July 21, 2015, or any
11 date thereafter that is convenient for the Court's calendar.

12 **STIPULATION**

13 Based on the foregoing Recitals, and with the Court's approval, Plaintiff and Defendant
14 agree and stipulate as follows:

15 1. The Case Management Conference presently scheduled for March 17, 2015, at 1:30
16 p.m. shall, with the Court's approval, be continued to July 21, 2015 at 1:30 p.m. or any convenient
17 date thereafter;

18 2. The parties shall submit a joint case management statement 7 days in advance of
19 the date of the further Case Management Conference; and

20 3. All deadlines related to the case management conference date shall be reset to
21 coordinate with the new initial case management conference date set by the Court.
