**AMENDED ORDER GRANTING
 PARTIES' STIPULATED REQUEST FOR
 SEVEN DAY EXTENSION OF TIME TO
 MOVE TO COMPEL**

1 The parties' Stipulated Request for Seven Day Extension of Time to Move to Compel, from
2 Friday, May 22, 2015 to Friday, May 29, 2015, is GRANTED. If the parties are unable to resolve
3 their discovery disputes, they shall comply with the discovery procedures set forth in this Court's
4 General Standing Order, available at <http://www.cand.uscourts.gov/kaworders>.

5 Furthermore, as stated on the record during the March 31 case management conference, the
6 parties shall complete mediation by the date of the next case management conference, which is
7 currently set for June 30, 2015. If the parties will not be able to complete mediation by that date, they
8 shall file declarations, by June 29, 2015, explaining why they will not meet that deadline and how
9 they expect to proceed. If the parties have completed mediation, and the case has settled, they shall
10 promptly notify the Court. This case is currently set for trial beginning on October 5, 2015, and that
11 date will not be changed.
