29 IT IS HEREBY STIPULATED, by and between Plaintiff Georgette Medina (Plaintiff) and
 30 Defendant Commissioner of Social Security (Defendant), by and through their respective counsel of
 31 record, that Plaintiff shall have an extension of time of twenty-eight (28) days to file Plaintiff's Motion
 32 For Summary Judgment. The current due date is September 30, 2014. The new due date will be
 33 October 28, 2014. This is the first extension of time requested by Plaintiff. Plaintiff requests this
