AMENDED CASE MANAGEMENT AND  
PRETRIAL ORDER FOR JURY TRIAL

12 1. TRIAL DATE

13 a. Jury trial will begin on July 11, 2016 at 9:00 a.m. at the U.S. District Court, 1301  
14 Clay Street, Oakland, California. For courtroom number and floor information, please check the  
15 Court's on-line calendar at [www.cand.uscourts.gov/judgeswkcal](http://www.cand.uscourts.gov/judgeswkcal) one week prior to trial, or call  
16 Susan Imbriani (Judge Westmore's Courtroom Deputy) at (510) 637-3525.

17 b. The length of the trial will be not more than 4 days. The Court may shorten the  
18 allotted time as it deems appropriate, and may also allocate a fixed number of hours for each side.  
19 Court hours for trial normally are 9:00 a.m. to 3:00 p.m., subject to the Court's availability.

20 2. DISCOVERY AND EXPERT DISCLOSURES

- 21 a. All non-expert discovery shall be completed by February 8, 2016.  
22 b. Experts shall be disclosed and reports provided by February 8, 2016.  
23 c. Rebuttal experts shall be disclosed and reports provided by February 22, 2016.  
24 d. All discovery from experts shall be completed by March 7, 2016.

25 3. PRETRIAL MOTIONS

- 26 a. The last day for hearing dispositive motions shall be April 7, 2016.  
27 b. Only one summary judgment motion may be filed by each side, absent leave of  
28 court. Leave of court may be sought if multiple parties comprise one or both sides.

1 Leave of court may be obtained by filing a motion for administrative relief pursuant  
2 to Civ. L. R. 7-11, or by requesting a case management conference or informal  
3 telephone conference.

4 c. Separate statements of undisputed facts in support of or in opposition to motions  
5 for summary judgment shall NOT be filed. See Civil L. R. 56-2. The parties may  
6 file a truly joint statement of undisputed facts only if all parties agree that the facts  
7 are undisputed.

8 d. Objections to evidence may no longer be filed separately but must be contained  
9 within the opposition or reply brief or memorandum. Civil L. R. 7-3.

10 e. Each party filing or opposing a motion shall also serve and file a proposed order  
11 which sets forth the relief or action sought and a short statement of the rationale of  
12 decision, including citation of authority that the party requests the court to adopt.

13 f. Chambers copies of each electronically-filed dispositive motion must include on  
14 each page the running header created by the ECF system and must be delivered to  
15 the Clerk's Office by noon the day following its filing. All documents must be  
16 stapled or bound by a two-pronged fastener, and all exhibits to declarations or  
17 requests for judicial notice must be tabbed.

18 g. In addition, counsel shall email copies of all motions for summary judgment in  
19 standard Word format (.doc or .docx, and not .pdf format) to  
20 kawpo@cand.uscourts.gov.

21 4. ALTERNATIVE DISPUTE RESOLUTION/SETTLEMENT CONFERENCE

22 The parties have stipulated to participate in private mediation, which shall be completed by  
23 February 1, 2016.

24 5. PRETRIAL CONFERENCE

25 a. A pretrial conference shall be held on June 28, 2016 at 3:00 p.m. Lead counsel  
26 who will try the case (or the party if pro se) must attend. The timing of disclosures required by  
27 Federal Rule of Civil Procedure 26(a)(3) and other pretrial disclosures shall be governed by this  
28 order.

1           b.       By May 27, 2016, thirty (30) days prior to the date of the pretrial conference, lead  
2 counsel shall meet and confer regarding:

- 3                   (1)     Preparation and content of the joint pretrial conference statement;  
4                   (2)     Preparation and exchange of pretrial materials to be served and lodged  
5                               pursuant to paragraph 5(c) below; and  
6                   (3)     Settlement of the action.

7           c.       By June 7, 2016, twenty (20) days prior to the pretrial conference, counsel and/or  
8 parties shall:

- 9                   (1)     Serve and file a joint pretrial statement that includes the pretrial disclosures  
10                               required by Federal Rule of Civil Procedure 26(a)(3) as well as the  
11                               following supplemental information:
- 12                               (a)     The Action.
- 13                                       (i)     Substance of the Action. A brief description of the substance  
14   of claims and defenses which remain to be decided.
- 15                                       (ii)    Relief Prayed. A detailed statement of all the relief claims,  
16   particularly itemizing all elements of damages claimed as  
17   well as witnesses, documents or other evidentiary material  
18   to be presented concerning the amount of those damages.
- 19                               (b)     The Factual Basis of the Action.
- 20                                       (i)     Undisputed Facts. A plain and concise statement of all  
21   relevant facts not reasonably disputable, as well as which  
22   facts parties will stipulate for incorporation into the trial  
23   record without the necessity of supporting testimony or  
24   exhibits.
- 25                                       (ii)    Disputed Factual Issues. A plain and concise statement of all  
26   disputed factual issues which remain to be decided.
- 27                                       (iii)   Agreed Statement. A statement assessing whether all or part  
28   of the action may be presented upon an agreed statement of

facts.

- (iv) Stipulations. A statement of stipulations requested or proposed for pretrial or trial purposes.
- (c) **Disputed Legal Issues**.  
Without extended legal argument, a concise statement of each disputed point of law concerning liability or relief, citing supporting statutes and decisions.
- (d) **Trial Preparation**.
  - (i) Witnesses to Be Called. With regard to witnesses disclosed pursuant to Federal Civil Rule of Civil Procedure 26(a)(3)(A), a brief statement describing the substance of the testimony to be given.
  - (ii) Estimate of Trial Time. An estimate of the number of hours needed for the presentation of each party's case, indicating possible reductions in time through proposed stipulations, agreed statements of facts, or expedited means of presenting testimony and exhibits.
  - (iii) Use of Discovery Responses. Designate excerpts from discovery that the parties intend to present at trial, other than solely for impeachment or rebuttal, from depositions specifying the witness page and line references, from interrogatory answers, or from responses to requests for admission.
- (e) **Trial Alternatives and Options**.
  - (i) Settlement Discussion. A statement summarizing the status of settlement negotiations and indicating whether further negotiations are likely to be productive.
  - (ii) Amendments, Dismissals. A statement of requested or

proposed amendments to pleadings or dismissals of parties,  
claims or defenses.

(f) Miscellaneous.

Any other subjects relevant to the trial of the action or material to its  
just, speedy and inexpensive determination.

- (2) Serve and file trial briefs (not to exceed 25 pages), which shall specify each cause of action and defense remaining to be tried along with a statement of the applicable legal standard (no opposition shall be filed);
- (3) Serve and file no more than ten motions in limine, which shall be filed in one document not to exceed 25 pages;
- (4) Serve and file proposed voir dire questions, jury instructions, verdict forms and excerpts from discovery that will be offered at trial (include a copy of the deposition testimony or admission). The parties shall submit proposed jury instructions **jointly**. If there are any instructions on which the parties cannot agree, those instructions may be submitted separately. The parties shall submit a **jointly prepared** proposed form of verdict, or, if the parties cannot agree, their respective proposals;
- (5) Serve and file an exhibit setting forth the qualifications and experience for each expert witness;
- (6) Serve and file a list of each party's exhibits by number (plaintiff) or letter (defendant), including a brief statement describing the substance and purpose of each exhibit and the name of the sponsoring witness;
- (7) Exchange exhibits which shall be premarked with an exhibit sticker tabbed and in binders. Plaintiff shall use numbers (1, 2, 3, etc.) and defendant shall use numbers preceded by a letter (A-1, A-2, A-3, etc.). Additional parties shall also use a letter preceding numbers (B-1, B-2, B-3, or C-1, C-2, C-3, etc.); and
- (8) Deliver three sets of all premarked exhibits to chambers, tabbed and in

1 binders (exhibits are not to be filed). The exhibits shall be marked with the  
2 following tag (or similar):

10 No party shall be permitted to call any witness or offer any exhibit in its case in chief that  
11 is not disclosed in its pretrial statement, exchanged with opposing counsel, and delivered to the  
12 Court, twenty (20) days prior to the pretrial conference, without leave of the Court and for good  
13 cause. Furthermore, all parties are reminded of their disclosure duties under Federal Rule of Civil  
14 Procedure 26. Any document or witness that should have been disclosed under Rule 26 will not  
15 be introduced at trial.

16 d. By June 17, 2016, ten (10) days prior to the pretrial conference, after meeting and  
17 conferring in a good faith attempt to resolve any objections, counsel and/or parties shall serve and  
18 file: (1) any objections to exhibits or to use of deposition excerpts or other discovery; (2) any  
19 objections to witnesses, including the qualifications of an expert witness; (3) any objection to  
20 proposed voir dire questions, jury instructions and verdict forms that the parties have been unable  
21 in good faith to resolve; (4) any opposition to a motion in limine. No replies shall be filed. The  
22 parties shall not file separate objections, apart from those contained in the motions in limine, to the  
23 opposing party's witness list, exhibit list or discovery designations.

24 e. All motions shall be heard at the pretrial conference unless otherwise ordered.

25 6. JURY TRIAL

26 a. The attached voir dire questionnaire (or similar) shall be given or presented to the  
27 venire members to be answered orally in Court. Counsel shall submit an agreed upon set of  
28 additional voir dire questions to be posed by the Court. Any voir dire questions on which counsel

1 cannot agree may be submitted separately. Counsel shall be allowed brief follow-up voir dire after  
2 the Court's questioning.

3 b. The following jury instructions from the Ninth Circuit Manual of Model Civil Jury  
4 Instructions (available on the Ninth Circuit website at <http://www.ce9.uscourts.gov>) shall be given  
5 absent objection: 1.1-1.2, 1.6-1.14, 1.18, 2.11, 3.1-3.3. Counsel shall submit jointly an agreed  
6 upon set of case specific instructions, using the Ninth Circuit Manual where appropriate. Do not  
7 submit duplicates of those listed above. Any instructions on which counsel cannot agree may be  
8 submitted separately. Each requested instruction shall be typed in full on a separate page with  
9 citations to the authority upon which it is based and a reference to the party submitting it. A  
10 second blind copy of each instruction and verdict form shall also be submitted omitting the  
11 citation to authority and the reference to the submitting party.

12 7. In addition to electronic filing, Counsel shall email copies of all proposed jury instructions,  
13 motions in limine, forms of verdict, and trial briefs in standard Word format (.doc or .docx, not  
14 .pdf format) to [kawpo@cand.uscourts.gov](mailto:kawpo@cand.uscourts.gov).
