1 This matter coming before the Court on Plaintiff's Motion for Final Approval of Joint Stipulation
2 of Class Settlement (the "Final Approval Motion"), and after review and consideration of the parties'
3 fully-executed Joint Stipulation of Class Settlement ("Settlement"), the papers in support of the Final
4 Approval Motion, Plaintiff's Motion for Attorneys' Fees, Costs and Enhancement Award, having heard
5 the arguments of counsel during hearing on August 3, 2017 at which no objectors appeared, and the
6 Court having issued an Order Granting Motion for Final Approval of Class Action Settlement and
7 Motion for Attorneys' Fees and Costs on August 25, 2017 (the "Final Approval Order") (ECF No. 83),

9 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

- 10 1. Final judgment in this matter is hereby entered in conformity with the terms of the
11 Settlement and the Final Approval Order;
- 12 2. This case is hereby dismissed with prejudice;

14 continuing jurisdiction over the implementation, interpretation, and enforcement of the Joint Stipulation
15 of Class Action Settlement with respect to all Parties to this action, and their counsel of record.
