2 IT IS HEREBY STIPULATED AND AGREED, by and between Plaintiffs SHERRY
3 SINGER, RYAN WILLIAMS, RYDER VANDERHEYDEN, STEVEN GRANT, and MICHAEL
4 TSAPATSARIS (“Plaintiffs”) and Defendant POSTMATES, INC. (“Defendant”), through their
5 respective counsel, as follows:

6 WHEREAS, the parties filed a Stipulation to on June 4, 2015, asking that the Court
