**AMENDED ORDER DENYING
PLAINTIFF’S MOTION FOR
APPOINTMENT OF COUNSEL;
DENYING HIS REQUEST FOR
EXTENSION OF TIME; AND
SETTING NEW BRIEFING
SCHEDULE**

Plaintiff, a state prisoner, has filed a *pro se* civil rights action pursuant to 42 U.S.C. § 1983, alleging that Defendants were deliberately indifferent to his safety and medical needs. Plaintiff and Defendants have consented to magistrate judge jurisdiction. Dkt. 1 at 11; Dkts. 22, 26. Therefore, this matter has been assigned to the undersigned Magistrate Judge. Dkts. 5, 6. In an Order dated October 9, 2015, the court issued its Order of Service. Dkt. 9. On December 8, 2015, Defendant J. Clark Kelso filed an answer to the complaint.¹ Dkt. 21.

Before the court is Plaintiff’s motion for appointment of counsel to represent him in this action. Dkt. 27. Also before the court is Plaintiff’s motion for an extension of time to prepare a response to Defendant Kelso’s answer. Dkt. 28.

PLAINTIFF’S REQUEST FOR APPOINTMENT OF COUNSEL

There is no constitutional right to counsel in a civil case unless an indigent litigant may lose his physical liberty if he loses the litigation. *See Lassiter v. Dep’t of Soc. Servs.*, 452 U.S. 18, 25 (1981); *Rand v. Rowland*, 113 F.3d 1520, 1525 (9th Cir. 1997) (no constitutional right to

1 counsel in section 1983 action), *withdrawn in part on other grounds on reh'g en banc*, 154 F.3d
2 952 (9th Cir. 1998) (en banc). The court may ask counsel to represent an indigent litigant under
3 28 U.S.C. § 1915 only in “exceptional circumstances,” the determination of which requires an
4 evaluation of both (1) the likelihood of success on the merits, and (2) the ability of the plaintiff to
5 articulate his claims *pro se* in light of the complexity of the legal issues involved. *See id.* at 1525;
6 *Terrell v. Brewer*, 935 F.2d 1015, 1017 (9th Cir. 1991); *Wilborn v. Escalderon*, 789 F.2d 1328,
7 1331 (9th Cir. 1986). Both of these factors must be viewed together before reaching a decision on
8 a request for counsel under section 1915. *See id.*

9 The court is unable to assess at this time whether exceptional circumstances exist which
10 would warrant seeking volunteer counsel to accept a pro bono appointment. The proceedings are
11 at an early stage and it is premature for the court to determine Plaintiff’s likelihood of success on
12 the merits. Moreover, Plaintiff has been able to articulate his claims adequately *pro se* in light of
13 the complexity of the issues involved. *See Agyeman v. Corrs. Corp. of Am.*, 390 F.3d 1101, 1103
14 (9th Cir. 2004). Accordingly, the request for appointment of counsel is DENIED without
15 prejudice.² Dkt. 27.

16 **PLAINTIFF’S MOTION FOR EXTENSION OF TIME**

17 Plaintiff’s motion for an extension of time to prepare a response to Defendant Kelso’s
18 answer is DENIED. Dkt. 28. Plaintiff need not respond to Defendant Kelso’s answer.

19 **NEW BRIEFING SCHEDULE**

20 In order to expedite the resolution of this case, the court issues a new briefing schedule.
21 Defendants shall serve and file a joint motion for summary judgment or other joint dispositive
22 motion by no later than **February 16, 2016**. If Defendants are of the opinion that this case cannot
23 be resolved by summary judgment or other dispositive motion, they shall so inform the court prior
24 to the date their motion is due.

26 ² This does not mean, however, that the court will not consider appointment of counsel at a later
27 juncture in the proceedings; that is, after Defendants have filed their dispositive motion such that
28 the court will be in a better position to consider the procedural and substantive matters at issue.
Therefore, Plaintiff may file a renewed motion for the appointment of counsel after Defendants’
dispositive motion has been filed. If the court decides that appointment of counsel is warranted at
that time, it will seek volunteer counsel to agree to represent Plaintiff pro bono.

Plaintiff's opposition to the joint dispositive motion shall be filed with the court and served on Defendants no later than **twenty-eight (28) days** after the date on which Defendants' joint dispositive motion is filed.

Defendants shall file a reply brief no later than **fourteen (14) days** after the date Plaintiff's opposition is filed.

This Order terminates Docket Nos. 27 and 28.
